## 2026 ALL AGE TB FALL SALE · September 3, 2026

### Iowa State Fairgrounds Cattle Barn Yearlings · Weanlings · Broodmares · Stallions · Horses of Racing Age

- **Entry Fee: \$300 per horse (non-refundable)**
- **Deadline: Must be received in ITBOA office by Noon on June 16, 2026 (not postmarked)**
- **Late Entry Fee: \$400 (accepted through August 3, 2026)**
- **ITBOA Membership: Required for both owner and consignor/agent. Membership fees not paid before the sale will be deducted from sale proceeds.**

- **5% commission on all horses sold**
- **If horse is not sold, 3% of the final bid or \$100 (whichever is greater) is owed**
- **Minimum bid accepted: \$500**
- **No Sale Fee will be based on the reserve price (if one is set); otherwise, it will be based on the last bid**

### REQUIRED DOCUMENTS (DUE BEFORE SALE)

- Jockey Club Certificate (with Iowa stamp if IA-bred) must be received before the sale
- Health Certificate (dated within 10 days of sale)
- Negative Coggins (dated within 1 year of sale)

### BROODMARES (additional info required)

- Indicate if: In Foal, Barren, Slipped, Not Bred
- Include Stallion Service Certificate or notarized statement that mare is free of lien
- Veterinary certificate within 10 days of sale stating either:
  - Mare is in foal (based on manual exam), or
  - Mare is barren and breeding sound

## Consignment Terms

- By submitting this contract, I confirm that I am the rightful owner of each horse listed and that all horses are free of any liens. I give ITBOA permission to act on my behalf during the sale, including transferring ownership and receiving payment. If any disputes arise about ownership, identity, or proceeds, I agree to cover any resulting costs or legal fees.
- Entry fees are \$300 per horse (or \$400 for late entries). These fees are non-refundable. A 5% sales commission will be deducted from the final sale price of each horse. If a horse is not sold, I agree to pay either 3% of the final bid or \$100—whichever is more. This fee is earned once the auctioneer's hammer falls, even if the sale is voided.
- Sale proceeds may be held by ITBOA for up to 30 days. If a buyer fails to pay or is found financially unreliable, the horse may be resold or returned to me. In such cases, I may not recover the original sale price, and ITBOA is not responsible for any loss.
- After I submit this consignment, I will not privately sell or otherwise remove any listed horse. If I do, I will owe a \$500 withdrawal fee. Horses may be withdrawn due to illness or injury with a vet certificate before the sale. If ITBOA's vet disagrees, a third-party vet will be consulted, and their decision is final.
- Any horse withdrawn for reasons other than injury or illness (verified by a vet) will incur a \$500 fee, due on sale day. ITBOA may waive this fee at their discretion.
- ITBOA has full authority to reject entries, assign stall space, set the sale order, and decide what announcements are made during the sale. Jockey Club papers must be submitted before the sale. If not received, proceeds will be held until they are. If a horse is not sold, ITBOA may retain the papers until all charges are paid.
- Broodmares must come with a veterinary certificate confirming either pregnancy or breeding soundness, based on an exam within 10 days before the sale. There is no guarantee on future breeding soundness beyond what is stated in that certificate.
- I agree to follow all ITBOA sale rules and understand that I must keep my account current to participate in this or any future sales.
- The minimum accepted bid for any horse is \$500. The no-sale fee will be based on the reserve price if one is set, or the last bid if not.
- ITBOA membership is required for both owners and consignors/agents. If not paid in advance, membership fees will be deducted from proceeds. Papers will not be released until all fees are paid in full.
- By signing this, I confirm that I have read and understood all sale terms. I know this is a legally binding contract and may consult an attorney if I have questions.
